Who CRICED are

- Apply and arrive — offers, deposits, CAS and visa, guardianship and travel.

This guide is free and unbiased. We are paid by partner schools, never by families, so our advice on whether a school suits your child is not affected by your budget.

Entry points and timeline

UK schools admit at fixed points. Applying at the right one gives your child the widest choice of schools and the best chance of a scholarship.

Entry point	Age	What it suits
Year 7 (11+)	11-12	Families moving early; smoothest academic and social settling.
Year 9 (13+)	13-14	The largest UK boarding intake; two years before GCSE.
Sixth Form (16+)	16-17	A Levels or the IB; strong option for able, independent pupils.

A realistic 12-18 month plan

When	What happens
18-15 months before	Agree budget and priorities; build a shortlist; register interest with schools.
15-12 months	Sit UKiset or school assessments; collect school reports and references.
12-9 months	Interviews (usually online); cricket footage or profile submitted where relevant.
9-6 months	Offers and scholarship decisions; accept a place and pay the deposit.
6-3 months	Appoint a UK guardian; school issues the CAS; apply for the Child Student visa.
3-0 months	Uniform and kit, flights, arrival and settling-in arrangements.

Late applications are sometimes still possible — schools occasionally have places after the main round — but the choice narrows and scholarship funds are usually committed.

Fees and the true total cost

Full boarding at UK independent schools is commonly quoted between roughly £30,000 and £50,000+ per year. The headline fee is not the whole picture, so we always work through indicative totals with families before shortlisting.

For families in Pakistan, £30,000–£50,000 a year is broadly PKR 11 million to PKR 18 million at current exchange rates, before flights, guardianship and one-off registration and deposit fees. We work through indicative totals in rupees with you before you shortlist.

Budget beyond the headline fee

Cost	Typical scale	Notes
Registration fee	£100–£350	Per school, non-refundable, paid at application.
Deposit	One term's fees	Usually refundable against the final term.
Guardianship	£1,500–£4,000 / year	Required for boarders under 18.
Flights and exeats	Varies	Half-term and holiday travel; some pupils stay with guardians.
Uniform, kit, trips	£1,000–£3,000 / year	Cricket kit, tours and school trips are extra.
EAL or extra tuition	£30–£70 / session	Where English support is recommended.

Exchange rates move, and schools raise fees annually. We advise families to plan on the full five- or seven-year cost of the school route, not just year one.

Scholarships, awards and bursaries

Most awards are a percentage of fees rather than the full amount, and availability differs sharply by school. We flag which of your shortlisted schools award them, and when to apply.

Cricket and sport awards

Offered by schools with serious programmes. Assessed on footage, performance data, a trial where possible, and a coach reference. Commonly 5–25% of fees, sometimes with coaching or kit included.

Academic scholarships

Awarded on entrance examination and interview performance. Often modest in value but carry real standing within the school and can be topped up by a means-tested bursary.

Music, art, drama and all-rounder awards

Frequently overlooked by overseas families. A strong second discipline alongside cricket can make a candidate distinctive, and all-rounder awards exist for exactly that profile.

Means-tested bursaries

Many schools prioritise UK-domiciled families for bursaries, and visa rules require overseas families to evidence they can meet fees. Treat bursaries as a possible top-up, never as the basis of your plan.

What strengthens an application: consistent school reports, a clear English level, two years of cricket performance evidence, a coach who will speak for your child, and an application submitted in the main round rather than late.

Visas, CAS and guardianship

Boarders study on the UK Child Student visa. The school acts as sponsor and issues a CAS (Confirmation of Acceptance for Studies) once a place is confirmed and the deposit is paid. The visa application follows the CAS — it cannot be made before it.

What you will need

- The CAS reference issued by the school.
- Evidence of funds for fees and living costs, held for the required period.
- Parental consent and proof of the relationship to the child.
- Tuberculosis test certificate where required for your country.
- Details of the care and accommodation arrangements in the UK.

Guardianship

Schools require a UK-based guardian for boarders under 18: an adult responsible for the child during exeats, half-terms and emergencies. Families use either a trusted relative in the UK or a professional guardianship organisation. Families in Pakistan most often appoint a professional guardianship organisation recommended by the school, and we can explain how this works and what it costs.

Start guardianship early. Schools will not release a CAS until care arrangements are confirmed, and a delay here is the most common reason a September start slips.

Judging cricket provision honestly

Every school prospectus shows a cricket photograph. Provision varies enormously, and this is where families most often get it wrong. Ask these questions of any school on your list:

- Who coaches, and what are their qualifications and playing background?
- Is there an indoor centre for winter, and how much winter net time does a pupil actually get?
- How many fixtures does each team play across a summer term?
- What are the links to club and county age-group cricket, and who has progressed recently?
- How is cricket balanced against academic demands in GCSE and A Level years?
- Is there a girls' programme with real fixtures, or only mixed junior cricket?

The best fit is rarely the most famous name. It is the school where your child will play, be coached properly, and still achieve the grades that keep university options open.
